ORDER:-

In the G.O. 1st read above, Government have issued orders constituting Tender Committee for procurement of various agricultural inputs and farm machinery to be distributed under subsidy to the farmers under different schemes being implemented by the Department of Agriculture during 2014-15 and thereafter. Government have identified the Managing Director, A.P.MARKFED as Chairman for finalization of all tenders related to fertilizers.

- 2. In reference 2nd read above, the Director of Agriculture, A.P. Hyderabad while furnishing the proceedings of the Tender Committee and informed that the Tender Committee has finalized the rate of Zinc Sulphate-21% @ Rs.37,400/- Per Metric Tonne inclusive of all taxes on FOL delivery basis (i.e., Rs.35,900/- being per MT cost and Rs.1,500/-being the Nodal Agency margin per Metric Tonne), Zinc Sulphate-33% @ Rs.1,00,000/- Per Metric Tonne inclusive of all taxes on FOL delivery basis (Rs.95,000/- being per MT cost and Rs.5,000/-(5%) being the Nodal Agency margin per Metric Tonne) and Zinc Sulphate-12% @ Rs.3,76,000/- Per Metric Tonne inclusive of all taxes on FOL delivery basis (Rs.3,58,000/- per MT cost and Rs.18,000/- (5%) being the Nodal Agency margin per Metric Tonne) during the year 2016-17.
- 3. The Director of Agriculture, A.P., Hyderabad has requested the Government, to accord permission to distribute Zinc Sulphate on 50% subsidy under departmental schemes at the rates finalised by the Tender Committee during 2016-17 @Rs.37,400/-per Mt of Zinc sulphate(21%) for 9921 M.Ts., Rs.1,00,000/- per Mt. of Zinc sulphate 33% for 463 M.Ts., and Rs.3,76,000/- of Zinc EDTA 12% for 492 M.Ts., and nominate AP MARKFED as Nodal Agency for supply of Zinc (21%), Zinc (33%) and Zinc (12%) to all districts in the state of Andhra Pradesh.
- 4. Government after careful examination, hereby approve and accord permission to distribute Zinc Sulphate on 50% subsidy under departmental schemes at the rates finalised by the Tender Committee during 2016-17 i.e., @Rs.37,400/-per Mt of Zinc sulphate(21%) for 9921 M.Ts., Rs.1,00,000/- per Mt. of Zinc sulphate 33% for 463 M.Ts., and Rs.3,76,000/- of Zinc EDTA 12% for 492 M.Ts., as per the guidelines of the Government of India subject to meeting the expenditure within the budget allocation. Government also hereby nominate A.P. MARKFED as Nodal Agency for supply of Zinc Sulphate-21%; 33% and EDTA 12% in all districts of the State of Andhra Pradesh during the year 2016-17.

5. The Director Agriculture, A.P., Hyderabad shall take further necessary action immediately. He shall also issue detailed guidelines to monitor the entire supplies.
