ORDER:-

In the G.O. 1st read above, orders were issued preparing the panel of eligible Assistant Director of Agriculture for promotion to the post of Deputy Director of Agriculture for the panel year 2016-17 and in the said G.O., the name of Sri D. Venkateswarlu was considered and included in the Panel against R.P. 93 and mentioned that promotion should be deferred until the termination of disciplinary proceedings pending against him.

- 2. In the Memos. 2^{nd} and 3^{rd} read above, orders were issued dropping the disciplinary cases pending against Sri D. Venkateswarlu, Assistant Director of Agriculture.
- 3. In the representation 4^{th} read above, Sri D. Venkateswarlu, Assistant Director of Agriculture has requested for promotion during the panel year 2016-17 in the cadre of Deputy Director of Agriculture, since all the disciplinary cases pending against him, were dropped.
- 4. The Special Commissioner of Agriculture, A.P., Guntur has requested to consider for promotion and issue necessary postings orders in the cadre of Deputy Director of Agriculture.

- 5. Accordingly, under Rule 10(a) of the A.P. State & Subordinate Service Rules, 1996, Sri D. Venkateswarlu, Assistant Director of Agriculture is hereby appointed by transfer on promotion to the post of Deputy Director of Agriculture notionally on par with his junior during the panel year 2016-17 in the scale of pay of Rs.49,870/- Rs.1,00,770/- plus usual allowances admissible under the rules in force from time to time.
- 6. The appointment order in para 5 above is subject to the following conditions:-
- (a) it is purely temporary and on an adhoc basis and shall not confer any right for regular appointment and is liable to be reverted as Assistant Director of Agriculture at any time without notice and without assigning any reason thereof; and
- (b) the appointment is subject to outcome of W.Ps. / W.As. / R.Ps. / C.As., etc., if any, pending before the A.P. Administrative Tribunal / High Court or any other Courts.
- 7. Consequent on promotion as Deputy Director of Agriculture, Government hereby post Sri D. Venkateswarlu as Deputy Project Director, ATMA., in the Office of the Director, SAMETI, Guntur in the existing vacancy.
- 8. Sri D. Venkateswarlu should join the promotion post of Deputy Director of Agriculture / Deputy Project Director, ATMA., within 15 days from the date of receipt of this order. If he / she fails to join or evade joining by applying for leave or otherwise, within the stipulated time, he / she shall forfeit all his / her rights both for the present and future for the post of Deputy Director of Agriculture without any notice in terms of Rule 11(b) of the A.P. State and Sub-ordinate Service Rules, 1996 read with G.O.Ms.No.145, General Administration (Ser. D) Department, Dt.15.06.2004.
- 9. The Special Commissioner of Agriculture, A.P., Guntur is requested to intimate the date of joining of the above officer to the Government for information and record.
