Director of Agriculture and Director , APSSCA, Guntur as the Inquiring Authority to inquire into the charge framed against the said Government servant vide references 4<sup>th</sup> to 6<sup>th</sup> cited.

- 4. And, whereas, the Government consider it necessary to appoint a Presenting Officer to present the case on behalf of the Government in support of the article of charge against the said Government servant before the Inquiring Authority;
  - 1. Now, therefore, the Government in exercise of the powers conferred by sub-rule (5) (c) of rule 20 of APCS (CC&A) Rules, 1991, hereby appoints the Joint Director of Agriculture, Srikakulam District as the Presenting Officer to present the case on behalf of the Government in support of the article of charge against the said Government servants before the Inquiring Authority.
- 5. The Inquiring Authority so appointed shall complete the inquiry and furnish the inquiry report to Government within a month.
