AMENDMENT

In the Guidelines issued in G.O.Rt.No.363, Agri. & Coop. (Agri. I) Dept., dt.21.06.2017, the Point Nos.(13) and (14) shall be substituted with the following:-

- "13) Based on the sanction order of the Joint Director of Agriculture, A.P. AGROS shall release purchasing order on the concerned dealer / supplier and arrange the delivery of the Tractor to the beneficiary.
- 14) The beneficiary should pay the non-subsidy portion to the supplier. The supplier should deliver the Tractor to the beneficiary at the Office of the Assistant Director of Agriculture within (10) days from the date of receipt of the non-subsidy portion and submit the receipt of non-subsidy amount to the A.P. AGROS along with Invoice".
