Schedule of Empanelment

Terms of Reference & Eligibility criteria for manufacturers

- 1. The Price offer is for the year 2022-23. The price is entered by the Manufacturer for the products in the DBT portal.
- 2. Only manufacturing firms/ Authorized dealers who have entered into agreement with the department are eligible to participate in this Empanelment process.

(2.1) the manufacturer should submit the Authorization letter mentioning the details of the dealer authorized to participate in the Empanelment.

- 3. The farm equipment which posses test certificate should only be applied by the manufacturing firm.
- 4. If the implement is given for testing and waiting for Test certificate, in case of Land Preparatory equipment manufacturers are also eligible to participate provided they enclose the acknowledgement of the FMTTI /Institute and submit the copy of the test certificate within 6 months in 2022-23.
- 5. The manufacturer will have to submit Copy of the test certificate for each product along with leaflet.
- 6. The manufacturer will have to submit one photograph of 6*4 inches for each product that they are offering in DBT portal. One photograph of the manufacturing unit with the name of the manufacturing firm.
- 7. Variants which do not possess test certificates are not eligible for supplies under subsidy scheme.
- 8. The imported items which possess valid test certificate issued by designated Institute from DAC are only eligible for subsidy. The importer will be considered as an authorized importer/on behalf of manufacturer to the tested product. The importer should have after sale service facility in the districts. They should furnish the letter from principle manufacturer for selling the products in India and authorized to sell in AP.
- 9. The manufacturers should attach the list of dealers, address and their period of validity of dealership along with the contact details and any other information.
- 10. The manufacturer should have registered on www.agrimachinery.nic.in portal and mention the Login id.
- 11. The price quoted will be valid for one year.
- 12. Dept of Agriculture will approve the prices of machinery indicated by manufacturers in the DBT portal as per the recommendations of Price Monitoring Committee to define the upper threshold prices of firm wise machinery.
- 13. Farmers are made well aware that the price approved in the DBT portal are indicative prices only and are informed to purchase farm machinery from the suppliers approved in the DBT portal and should not exceed the market prices.

- 14. And farmers are encouraged to negotiate the prices with the dealers duly exploring the market prices to purchase farm machinery at competitive prices.
- 15. The authority (Commissioner of Agriculture) has the discretion to call for price negotiations for the products, if necessary, and may finalize the procedure.
- 16. The farm implement/equipment supplied must be covered with warranty for one year from the date of supply against any defective manufacture/workmanship, etc. The repairs/replacements shall be attended free of cost within the warranty period.
- 17. The Authority may levy a penalty on the manufacturer if found that supplied component are not conforming to quality parameter as stipulated in test certificate. The cost of such product/s would be recovered from the bank guarantee submitted by the manufacturer.
- 18. The full copy (one) of the test certificate for all the models and its variants are to be furnished.
- 19. The farmers will get the farm equipment by applying on DBT portal designed and development by M&T Division of DAC &FW, GOI.
- 20. The manufacturers whose product is in testing process are eligible to participate in Empanelment but should produce the test certificate before the supply in the financial year 2022-23.
- 21. The manufacturer will submit their price offer only for the product for which they have submitted the specification and applicable valid BIS certificate/quality parameter.
- 22. The Department has right to discontinue /reject the manufacturer, if found that product supplied by manufacturer is not as per the minimum specified IS standard and/or specification or its IS certification/applicable registration
- 23. The department has every right to check/ engage an agency to verify the quality of the products supplied during any part of the year at any district during the year.
- 24. The test certificates validity should be verified by the manufacturer with the testing Institutes as per the present norms as on the date of participation in Empanelment process.
- 25. The department may conduct site visit of manufacturing facility to ascertain the manufacturer status and manufacturing facility of the manufacturer. In case if the authority finds during the site visit that applicant is not a manufacturer, the manufacturer shall be rejected in the DBT portal.
- 26. The price offered is inclusive of all taxes, transport and the farm equipment should be supplied to RBK in the Village.

Further, the rates quoted by the Firm/Dealer shall not be more than the prevailing market price of the same or similar equipment within or outside the State. If the contrary is proved, Dept will initiate action for blacklisting of the Firm/Dealer duly following the procedure.
- x. The Manufacturer should furnish the User manual and the Brochure/ leaflet to the customer who purchases the tarpaulins. Details of the coverage of Warranty period with Date stamp is to be given to customer at the time of delivery. Details of the service centers available nearby to the customer should be intimated to customer.
- xi. The manufacturer shall agree that in case of non-fulfillment of the obligation of supply of tarpaulins, as per beneficiary choice and as per the orders / Specifications /quality, shall allow the farmer group to buy from another manufacturing firm. The expenditure incurred/ claimed by group for travel has to be borne by the manufacturer who failed to supply.
- xii. The agreement is valid up to 30-06-2023/as per the orders of the department issued from time to time.
- xiii. The beneficiary will place orders on the Manufacturer or its dealer for the required quantity along with the sanction letter of theDepartment.The Manufacturer/ dealer has to ensure the supply of the same immediately or within 10 days from the date of order unless mutually accepted in writing by the beneficiary also for the delay in receipt of farm equipment.
- xiv. The Department can take up verification on price, and quality from time to time in the interest of the farming community through 3rd party firm as decided by the department.
- xv. In the event of any failure to supply the indented quantity on time or in the event of the tarpaulins failing to supply which confirm to the specifications,the Department has the right to prosecute and take appropriate measures, besides initiating suitable legal action.
- xvi. The Manufacturer/dealer shall not deliver the tarpaulins without valid purchase order from the beneficiary.
- xvii. The manufacturers shall paint/ engrave/ emboss the stipulated information on every unit of tarpaulins supplied under the subsidy scheme of Dept. of Agriculture; SI.No. &Year; Weight; Name of the subsidy scheme; name of the supplying firm; on the machinery.

- As per DBT method, individual beneficiaries, have to purchase/procure tarpaulins by paying full cost and subsidy to be transferred to beneficiary accounts after grounding of the unit by the State Govt on the processing of subsidy claim.
- xviii. Dept of Agriculture is adopting DBT method for subsidy sanction and release where in the eligible subsidy amount is sanctioned and released to the beneficiary farmer.
- xxvii. In case of any disputes/ difference arising out of the agreement the parties should attempt to settle the dispute through mutual and amicable discussions. If the dispute is not settled through such discussions, the matter shall be referred/settled as per Arbitration & Conciliation Act.1996.
- xxviii. Any notice or communication or letter addressed to the addressee of either party mentioned in this agreement is deemed to be sufficient notice for all purposes of this Agreement.
- xxix. The place where this agreement is implemented, it is mutually undertaken and agreed by and between the parties and this agreement shall be deemed to have been entered by the parties concerned at the Courts of law situated at Guntur only shall have the jurisdiction to entertain the said litigation arising out of this Agreement.

- 5. The manufacturer will have to submit Copy of the test certificate for each product along with leaflet.
- 6. The manufacturer will have to submit one photograph of 6*4 inches for each product that they are offering in DBT portal. One photograph of the manufacturing unit with the name of the manufacturing firm.
- 7. Variants which do not possess test certificates are not eligible for supplies under subsidy scheme.
- 8. The imported items which possess valid test certificate issued by designated Institute from DAC are only eligible for subsidy. The importer will be considered as an authorized importer/on behalf of manufacturer to the tested product. The importer should have after sale service facility in the districts. They should furnish the letter from principle manufacturer for selling the products in India and authorized to sell in AP.
