7. Specifications for the Mobile application

Purpose:

The mobile APP will be placed on the Kiosk to help farmers - within the village – to transact for hiring the equipment – from the Farmer Groups who establish (CHC) at RBK

village level and PACS through Mega Hubs at Mandal Level/ Assembly Constituency level to provide their agricultural machineries & equipment on rental basis - It should also have feature to enable ubarisation of already existing farm equipment in the Villages. Reg

Request for Proposal: The following features are to be enabled in the FM APP.

- 1. Multi language Mobile App platform : English, Telugu,
- 2. Stake Holders: Farmers Group/ Custom Hiring Center(CHC) operator
 Farmers (users)
 Government officer
- 3. Entry screen for each stake holder
- 4. Logins to enter data for each stake holder and also to see to reports,
- 5. Entry Screen to CHC Operator, to capture the details of implements in CHC, contact details, geological location of implements, rental charges, terms and conditions(static), confirmation of bookings, alerts before hours before execution of work, SMS alerts to customers on confirmation of booking, Ending of transaction details, Payment receipt details, closing of booking, etc.,
- 6. Registration of farmers in the villages/ (transfer of data of farmers in the village available in the kiosk), location, mandal, district, mobile nos, , search bar for availability of implements, booking details, calling facility(offline), negotiating the charges(offline), Confirmation alerts(sms), cancellation of bookings, digital payment facility, etc., Taking the data into master screens
- 7. For government officials to track the equipment which possess GPS device. Record/monitoring of the machinery in the Shed of the CHC(protection) against thefts,
- 8. Alerting the RBK/Official about crossing the village/ Mandal/District borders, entry screen to CHC owner to enter the permission to cross borders, screen to post the number of hours worked, charges levied, income generated, capturing the repair details about the transactions

- done during the day, implement wise,
- 9. Dash board to capture information on income generated every day from a particular CHC, village wise, Hub Wise(mandal level), district wise, ADA division wise.
- **10.** To capture the monitoring made by Government officials to the CHC by documenting/recording their visits. Inspection of VAA at EOD/ BOD details
- 11. Details(mobile, contact person, Toll free, email) to manufacturer/ dealer/ service personnel of the equipments available in the CHC by capturing the details through Invoice at the time of purchase. Capturing the beginning of warranty and end of warranty period.
- 12. Details to capture the idle time of the equipment on monthly basis
- 13. Details of income generated and balance available in Bank account. Reconciliation with bank account(once a month, off line) entry field to Government officer login.

- **15.** All the features of FARMS App should also be made available in the new app which is proposed now.
