The notional promotion as ADA to Sri K.Robert Paul in Zone II duly reexamining the grievance and rectification and reconstitution of the panel for the year 2004-05 in Zone-II as per the orders issued by the Government.

The Govt. have issued GO towards appointment orders not issued to Sri K. Robert Paul due to pendency of finalization of his social status and appointment orders issued during 2005 after finalization of ST status and permission accorded for revision of seniority and giving notional seniority. The details are furnished here under.

Sri.K.Robert Paul was selected as Agricultural officer under ST Category during limited recruitment of SCs and STs in the year 1997 in zone-II but he was not issued appointment orders whereas others were issued appointment orders during 1997. His case was referred to the Commissioner, Tribal Welfare to produce the latest community certificate . As he has failed to produce the latest community certificate before the Commissioner, Tribal Welfare as there was case pending before the District Collector, East Godavari about his social status under ST, he was not issued clearance. Hence the Department of Agriculture has not issued appointment orders even though he was selected by the Selection Committee along with others. Though the Hon'ble APAT, Hyderabad and the Honb'le AP High Court have supported his claim for appointment as Agricultural Officer in the OA No.9500/2002,WP No.22231/97 respectively, pending finalization of his social status, the department has not appointed him as Agricultural Officer stating that final enquiry report of District Collector, East Godavari and clearance from the Commissioner, Tribal Welfare A.P., Hyderabad is required to issue appointment Orders.

::2::

The District Collector, East Godavari district on completion of enquiry, has concluded that their community belongs to VALMIKI which is under ST and DLSC (District Level Screening Committee) has also confirmed that they belongs to VALMIKI under ST Community. Therefore, the MRO, Addateegala has issued latest caste Certificate No.1909, dt:09-07-2005, and the Commissioner, Tribal Welfare A.P., Hyderabad has also confirmed his ST claim and issued Clearance. Accordingly, he was issued appointment order as Agricultural Officer vide Pro.No.A7(1)273/97, dt:05.09.2005 based on the selection under ST Special drive recruitment made during the 1997. The Hon'ble Court has also issued final orders dt:28-2-2007 favoured the individual.

The individual has requested to consider his case keeping in view that he was selected for appointment during 1997 along with others i.e., who were appointed vide Pro.No.Esst.VII(3)273/97, dt:02-08-1997 and seniority may be given from 1997, otherwise he may put to great personal loss and injustice about the benefits of the selection as Agricultural Officer made during 1997 as the delay in issue of appointment orders is without any fault of him and the lapse of (8) years is caused administrative reasons, he is being penalized due to which he is forgoing benefits of service such as seniority, promotion, pensionary benefits etc., and the juniors who were selected after 1997 were already promoted as ADAs under ST quota and the individual put to loss in promotion.

Further Govt. has observed that the abnormal delay in issuing appointment orders, was not the fault of the individual and so he should not be punished.

The Government have decided to consider the request of Sri.K. Robert Paul for giving notional seniority from the date of his selection i.e., from 1997 since he was selected for appointment as Agricultural Officer during 1997 along with others i.e., who were appointed vide pro.No.Esst.VII(3)273/97 dt:02-08-1997 and accordingly, accord permission to this office to revise the seniority list and give notional seniority to Sri.K.Robert Paul in the category of Agricultural Officer from the date of his selection during 1997 along with others i.e., who were appointed vide pro.No.Esst.VII(3)273/97 dt:02-08-1997 duly following the due procedure in force.

In this connection, this office has revised the seniority list and communicated to the affected individuals calling for objections if any, and further this office has finalized the seniority w e f 2-8-1997. Since no objections were received in the stipulated time from the affected individuals as per rules and regulation in vogue.

In view of above the seniority in the cadre of Asst. Director of Agriculture has to be revised and the name of Sri.K.Robert Paul be placed in the roster point 33(ST) which was carried forward during the panel year 2004-05 to till date.

In this connection, this office has requested the Govt. A&C Dept., to accord permission for conducting review DPC /Screening Committee meeting for giving notional promotion as ADA during the panel year 2004-05.

Further, the Govt have accorded permission to convene Review DPC/Screening Committee meeting to review the panel of Agriculture Officers for promotion as Asst. Director of Agriculture for the panel year 2004-05.

In this connection a review DPC conducted for considering the promotion of AOs as ADAs during the panel year 2004-05 in Zone-II, duly rectifying and reconstituting the approved panel for the year 2004-05 as per Government Orders. Hence, Sri.K.Robert Paul,ADA(SC) Rampachodavarm,E.G.Dt., is here by notionally promoted at 33 Roster point which was carry forwarded as ADA on par with his junior Sri.B.V.S.C.Hari,during the panel year 2004-05.

In this regard, the revised integrated seniority list is prepared and appended and the same may be for calling the objections if any within 15 days from the date of receipt of this memo or otherwise objections not received within stipulated time to this office. It will be treated as holds good.
