In the reference 1st cited the Principal Scientist & Head AICRP on Micronutrients, ARI, ANGRAU, Rajendranagar, Hyderabad has furnished the project proposal regarding the Soil Health Card Development for Kuppam.

2. In the reference 3rd cited, the Commissioner and Director of Agriculture, A.P. Hyderabad has reported that the Acharya N.G. Ranga Agricultural University (ANGRAU) submitted a project proposal titled “Soil Health Card Development for Convergence into Kuppam Agricultural Action Plan” with the main objective to develop soil fertility (Macro and Micronutrients) status for all 220 villages in Kuppam to advocate fertilizer usage for improved productivity of crop and enhanced nutrient efficiency and also to integrate this information into data base of Agricultural Action Plan of Kuppam to be developed by the Government of Andhra Pradesh. Under this project ANGRAU has proposed to analyze @ 1 per 10ha in 49732 ha (a total of 5000 samples) of cultivated area of Kuppam area to integrate this information into GIS platform. The Budget proposed for the project is as follows:

The Commissioner & Director of Agriculture, A.P., has further reported that under Normal State Plan 2014-15 an amount of Rs.876.05 lakhs was allocated towards “Buildings for Agriculture Department Scheme” under head of account 4401-00-800-11-74. As there is no separate allocation for implementing this project, he has requested to divert the funds from the above head for sanctioning and release of Rs.110 lakhs to ANGRAU towards implementing this project to derive reasonable soil health status of Kuppam area of Chittoor District for improving productivity of crops and reduce wastage of fertilizers.
