In the G.O. 1<sup>st</sup> read above, Sri K. Hemamaheswara Rao, Joint Director of Agriculture, who has been reported in the State of Andhra Pradesh on his tentative allocation and waiting for posting, has been posted as Project Director, ATMA, West Godavari, Eluru and Smt. Y. Ananda Kumari, Project Director, ATMA., Vijayawada has been transferred and posted as Joint Director of Agriculture, Nellore.

2. In the orders 3<sup>rd</sup> read above, the Hon'ble A.P. Administrative Tribunal while suspending the impugned proceedings issued in G.O.Rt.No.596, Agriculture & Cooperation (Agri. I) Dept., dt.15.08.2015, have directed the respondents to consider the case of the applicant for posting as Joint Director of Agriculture in the existing vacancy.
