ORDER:

In the Government Order first read above Government have authorized the Society for Elimination of Rural Poverty (SERP) as Service Provider to take up the Non-Loanee / Tenant farmers enrollment under PMFBY & WBCIS during Kharif, 2016.

2. In the Government Order second read above Government have accorded administrative approval for implementation of Pradhan Manatri Fasal Bima Yojana (PMFBY) & Weather Based Crop Insurance Scheme (WBCIS) in the State during Rabi, 2016-17.

3. In the letter third read above, the Director of Agriculture, A.P., Guntur has requested the Government to issue orders, authorizing the SERP as Service Provider to take up the Non-Loanee / Tenant farmers enrollment under PMFBY & WBCIS during Rabi, 2016-17 season in the State.

4. In the circumstance reported by the Director of Agriculture, A.P., Guntur and after careful examination of the entire matter, Government hereby authorise the Society for Elimination of Rural Poverty (SERP) as Service Provider to take up the Non-Loanee / Tenant farmers enrollment under PMFBY & WBCIS during Rabi, 2016-17 season in the State. The broad responsibilities of the SERP are as follows:

1. Identification of required SHG women in all the villages.
2. Filling up of the proposal forms for individual farmers.
3. Collect all the documents as prescribed in the scheme for e.g. Certificate of Cultivation issued by MAO, PPB, Copy of Aadhar Card, Copy of Bank Pass book etc. These documents should be self-attested by the farmer.
4. Take photocopies or printing of stationary or any other document where ever required to avoid any kind of delay.

5. All the data entry related with the scheme will be done at Mandal level by Mandal Samakhya in the prescribed format of the respective Implementing Insurance companies. The same needs to be submitted to Implementing Insurance Company in soft copy as well as hard copy with a covering letter in the format as prescribed by the Implementing Insurance Companies.
  6. Due diligence has to be done by the Mandal Samakhya to check the complete documents and the proposal forms. Any incomplete proposal form or incomplete documentation as prescribed in the scheme should not be accepted by the Mandal Samakhya from the SHG's.
  7. Insurance Company will issue the insurance certificate for farmers. It will be the responsibility of Mandal Samakhya to get the same distributed to the respective farmers.
  8. Service Fee of 6% ( 4% Commission +2% towards data entry of proposals and misc.) of farmer share of premium collected would be paid by the Implementing Insurance Companies to the SERP at State Level.
5. The Director of Agriculture, A.P., Guntur shall take necessary action accordingly.
