In the letter read above, the Director of Agriculture, A.P., Guntur has stated that an amount of Rs.321.60 lakhs was Proposed under the Scheme "IT enabled programme-supply of tabs and other equipment to staff" in the Budget Estimates 2016-17. He has also stated that quarter wise budget distribution was submitted in the DTA Portal. Accordingly, CBRO was issued vide G.O.Ms.No.51, Finance (Budget-1) Dept., Dt.01.04.2016 and DT Authorization was issued for the first quarter budget and an amount of Rs. 180.00 lakhs is proposed for monthly charges of data cables. But the District Treasuries are not accepting the bills and requesting to change the detailed head as "130/131" instead of "130/132".

2. The Director of Agriculture, A.P., Guntur, is therefore, requested to re-appropriate an amount of Rs.180.00 lakhs from "130/132 Other Office Expenses" to "130 Other Office Expenses /131 Service Postage, Telegram and Telephone Charges" towards monthly internet charges of the 6000 TABs already supplied to the field level Extension functionaries.

Accordingly, Government after careful examination, hereby accord administrative sanction to the Director of Agriculture, A.P., Guntur for an amount of Rs.180.00 lakhs from "130/132 Other Office Expenses" to "130 Other Office Expenses /131 Service Postage, Telegram and Telephone Charges" towards monthly internet charges of the 6000 TABs already supplied to the field level Extension functionaries.

4. The Director of Agriculture, A.P., Guntur is requested to furnish re-appropriation proposals for taking further necessary action.
