**ORDER:-**

Under Rule 10(a) of the A.P. State & Subordinate Service Rules, 1996, Sri S. Raju, Assistant Director of Agriculture is hereby appointed by transfer on promotion to the post of Deputy Director of Agriculture during the panel year 2016-17 in the scale of pay of Rs.49,870/- - Rs.1,00,770/- plus usual allowances admissible under the rules in force from time to time.

2. Consequent on promotion, Government hereby post Sri S. Raju as Deputy Director of Agriculture (Agro), Office of the Joint Director of Agriculture, YSR District, Kadapa, in the existing vacancy.

3. The appointment order in para -1 above is subject to the following conditions:-

(a) it is purely temporary and on an adhoc basis and shall not confer any right for regular appointment and is liable to be reverted as Assistant Director of Agriculture at any time without notice and without assigning any reason thereof;

(b) the appointment is subject to outcome of W.Ps. / W.As. / R.Ps. / C.As., etc., if any, pending before the A.P. Administrative Tribunal / High Court or any other Courts; and

The individual should join the promotion post of Deputy Director of Agriculture (Agro), Office of the Joint Director of Agriculture, YSR District, Kadapa, within 15 days from the date of receipt of this order. If he fails to join or evade joining by applying for leave or otherwise, within the stipulated time, he shall forfeit all his rights both for the present and future for the post of Deputy Director of Agriculture without any notice in terms of Rule 11(b) of the A.P. State and Sub-ordinate Service Rules, 1996 read with G.O.Ms.No.145, General Administration (Ser. D) Department, Dt.15.06.2004.
