ORDER:

The vision of the Government is to develop Andhra Pradesh as a Global Seeds Hub and to ensure that quality seeds reach every smallholder farmer in Andhra Pradesh. The State Government, in collaboration with the Seed Science Center of Iowa State University (ISU) proposes to establish a Mega Seed Park (MSP) in Kurnool district. The goal of the Mega Seed Park is to achieve and ensure continued seed security through science-led innovations and policies. The expected outcome is enhancement of Andhra Pradesh's capacity to increase agricultural productivity and help ensure food security through seed security. Mega Seed Park will serve as the platform to accelerate the seed industry and related human capital development in the state and to create wealth for the state as well as the farming community.

2. The Government of Andhra Pradesh have entered into a project agreement with Iowa State University of Science and Technology on 05.04.2017 for establishing the Andhra Pradesh Seed Research and Technology Center (APSRTC) and a Mega Seed Park (MSP) in Andhra Pradesh with an aim to evolve as a Global Center of Excellence in seed technology, innovation and business for Asia. This project aims at an Integrated Systems Approach consisting of the following thematic areas:

1. Seed Research and Innovations
2. Seed Policy and Regulations
3. Seed Enterprise Development through the Mega Seed Park
4. Global Seed Programs
5. Capacity Strengthening in the Seed Sector.

3. Government have decided to form a Special Purpose vehicle (SPV) to speed up the activities of implementation Andhra Pradesh-Iowa State University Mega Seed Park. The Government of Andhra Pradesh have also decided to constitute a Board of Directors with a following Composition:-
