ORDER:-

In the references 2<sup>nd</sup> and 4<sup>th</sup> read above, the Special Commissioner of Agriculture, A.P., Guntur has submitted proposals for considering the inter-state transfer of Smt. Soyaba Tabassum, Agricultural Officer (Zone II), presently working on Inter-state deputation as Agricultural Officer (T), Office of the District Agriculture Officer, Jogulamba Gadwal District, Telangana State and Sri Y. Vittal Kishore, Agricultural Officer Telangana State (Zone V) presently working on deputation as Agricultural Officer (ZBNF), Office of the Joint Director of Agriculture, Visakhapatnam from the State of Andhra Pradesh to the State of Telangana and vice-versa on mutual basis.

2. In the Letters 3<sup>rd</sup> and 5<sup>th</sup> read above, the APC & Principal Secretary to Government, Agriculture & Cooperation Department, Telangana Secretariat, Hyderabad was requested to give the consent of the Government of Telangana for the aforesaid inter-state transfer on mutual basis, for taking further necessary action in the matter.

3. In the G.O. 6<sup>th</sup> read above, the Government of Telangana have issued orders for Inter-State transfer on mutual basis in respect of Sri Y. Vittal Kishore, Agriculture Officer (Zone V), Telangana and presently working as Agricultural Officer, Dharmaram, Peddapally District and Smt. Soyaba Tabassum, Agricultural Officer, A.P. State from the State of Andhra Pradesh to the State of Telangana on vice-versa, subject to condition that they will forego their seniority in the present working Zones

and take last rank next to the last regular Mandal Agriculture Officer in the New Zones of the respective State, in terms of the orders issued in the Cir. Memo. Dt.07.08.2017. In the said G.O., it was also directed the Commissioner of Agriculture, Hyderabad to relieve Sri Y. Vittal Kishore, Agriculture Officer with immediate effect with a direction to report before the Special Chief Secretary to Government (FAC), Agriculture & Cooperation Dept., Govt. of Andhra Pradesh and also requested the Agriculture & Cooperation Department, Government of Andhra Pradesh to relieve Smt. Soyaba Tabassum, Agriculture Officer, A.P. State with a direction to report before the APC & Principal Secretary to Government, Agriculture & Cooperation Department, Government of Telangana, Hyderabad.

4. Accordingly, Government after careful examination of the matter, hereby order for the inter-state transfer of Smt. Soyaba Tabassum, Agricultural Officer (Zone II), presently working on Inter-state deputation as Agricultural Officer (T), Office of the District Agriculture Officer, Jogulamba Gadwal District, Telangana State and Sri Y. Vittal Kishore, Agricultural Officer Telangana State (Zone V) presently working on deputation as Agricultural Officer (ZBNF), Office of the Joint Director of Agriculture, Visakhapatnam, from the State of Andhra Pradesh to the State of Telangana vice-versa on mutual basis, subject to condition to take last rank next to the last regular candidate in the new respective States and forego seniority in the existing State as well as lien in terms of the instructions issued in the Circular Memo. 1<sup>st</sup> read above.

5. The Special Commissioner of Agriculture, A.P., Guntur is requested to relieve Smt. Soyaba Tabassum, Agricultural Officer with immediate effect with a direction to report before the APC & Principal Secretary to Govt., Agriculture & Cooperation Department, Government of Telangana, Hyderabad.

6. The Special Commissioner of Agriculture, A.P., Guntur / the Commissioner of Agriculture, Government of Telangana, Hyderabad shall take further necessary action in the matter accordingly.
