Agriculture Department – Acharya N.G. Ranga Agricultural University - Allotment of 100.00 acres of land at State Seed Farm, Amaravati to Sri Venkateswara Veterinary University in exchange of allotment of 110.00 acres of SVVU Land, at Lam, Guntur to ANGRAU – Modification – Orders – Issued.

ORDER:-

In the G.O. 1st read above, Government have permitted Sri Venkateswara Veterinary University (SVVU) to transfer an extent of 110.00 Acres of land pertaining to SVVU adjacent to ANGRAU Research Station, Lam, Guntur District to the Acharya N.G Ranga Agricultural University, subject to the following conditions.

- A) An area of 100 acres of land available at Amaravati be transferred to Sri Venkateswara Veterinary University to grow fodder live stock of LRS, Lam.
- B) An amount of Rs. 12.00 crores (Rupees Twelve crores) be paid to the SVVU, Tirupati by the Department of Agriculture for meeting the expenditure i.e leveling, repairs to pumps and irrigation system, construction of compound wall, watchman quarters, farm sheds etc & also to meet the transport needs of fodder.

2. In the reference 2nd read above, the Special Commissioner of Agriculture, A.P., Guntur has submitted that, the entire farm land of SSF, Amaravati is required for establishment of State Level Institutions/Laboratories such as SAMETI, DNA Fingerprinting & Transgenic Crops Monitoring lab, pesticides Coding Centre, Fertilizer Quality Control Lab, Model Farm, Seed processing unit cum Seed Storage Godown (APSSDC Ltd) etc. The Government have already allotted 42.5 Acres to 7 institutions and 5.00 Acres to APPSSDC Ltd from the Seed Farm land. Funds of Rs.22.44 crores from RKVY Scheme are sanctioned for construction of 7 State Institutions pertaining to Agriculture Department and construction work is in progress.

3. The Special Commissioner of Agriculture has further submitted a meeting was convened with Senior Officers of Sri Venkateswara Veterinary University on transfer of land of State Seed Farm, Amaravati to SVV University on 11.10.2018 and the following extent of land of State Seed Farm, Amaravati and ANGRAU is available to spare for SV Veterinary University, Tirupati.

(P.T.O.)

- Left land being used as State Seed Farm : 15.50 Acres.
- Poramboku land available in Seed Farm : 11.00 Acres.

- Vacant land (under procession of ANGRAU
Which is Westside of Seed Farm) : 17.00 Acres.

Total land available : 43.50 Acres.

4. The Special Commissioner of Agriculture has accordingly requested the Government to revise the G.O.Ms.No.2, Agri.& Coop.(Agri.III) Dept., Dt.11.01.2017 for allocating the above 43.50 Acres land available in State Seed Farm, Amaravati (including the land under procession of ANGRAU) to Sri Venkateswara Veterinary University, Tirupati.

5. In the reference 3rd read above, the Registrar, ANGRAU has submitted that the 17.00 acres of land (which is west side of seed farm) is very much essential for ANGRAU for seed multiplication and is not possible to spare the said land to Sri Venkateswara Veterinary University.

6. Government after careful examination of the matter and in partial modification of the orders issued in G.O.1st read above, hereby permit the Special Commissioner of Agriculture, A.P., Guntur to allot Ac.43.50 of land available in the State Seed Farm, Amaravati as detailed below to Sri Venkateswara Veterinary University, Tirupati in exchange of allotment of 110.00 acres of SVVU Land at Lam, Guntur to ANGRAU.

- Left land being used as State Seed Farm : 15.50 Acres.
- Poramboku land available in Seed Farm : 11.00 Acres.

- Vacant land (under procession of ANGRAU
Which is Westside of Seed Farm) : 17.00 Acres.

Total land available : 43.50 Acres.

7. The Special Commissioner of Agriculture, A.P., Guntur and the Registrar, Acharya N.G Ranga Agricultural University, shall take further necessary action, accordingly.
