ORDER:

Whereas an Inquiry under rule 20 of the Andhra Pradesh Civil Services (CC&A) Rules, 1991 is being held against the following officers:

And, whereas the Government considered that an Common enquiry has to be conducted against Sri K.V.Subba Rao, Former Joint Director of Agriculture, Nellore and 4 others by appointing Enquiry Officer and Presenting Officer as per Sub-Rule (2) of Rule 20 and 20(5)(c) of APCS (CC&A) Rules, 1991 to inquire into the charges framed against above officers.

3. Now, therefore, the Government in exercise of the powers conferred by sub-rule (2) of Rule 20 of APCS (CC&A) Rules, 1991, hereby appointing Smt. Y. Sai Lakshmeeswari, Additional Director-I, O/o Commissioner of Agriculture, A.P., Guntur as Inquiry authority to conduct common Enquiry into the charges framed against the above said Government servants vide reference 3rd to 7th read above.

4. And, whereas, the Government consider it necessary to appoint a Presenting Officer to present the case on behalf of the Government in support of the article of charge against the above said Government servants before the Inquiry Authority.

5. Now, therefore, the Government in exercise of the powers conferred by sub-rule (5) (c) of rule 20 of APCS (CC&A) Rules, 1991, hereby appoint the JDA Nellore as Presenting Officer to present the case on behalf of the Government in support of
