**PRELIMINARY NOTIFICATION**

It is proposed to make the following amendments to the Andhra Pradesh Market Committee Employees (Pension-cum-Gratuity) Rules, 1980 issued in G.O.Ms.No.444, Food and Agriculture (Agri.IV) Department, dated:18.08.1980 and published in issue No.38 of R.S. to Part-I, Extra-ordinary of the Andhra Pradesh Gazette, dated:05.09.1980 in exercise of the powers conferred by sub-section(1) and clause(iv) of sub-section of section 33 of the Andhra Pradesh (Agricultural Produce and Livestock) Markets Act, 1966 (Act.No.16 of 1966) and the same is hereby published for general information in the Andhra Pradesh Gazette as required under sub-section (4) of section 33 of the said Act.

2. Notice is hereby given that the said draft amendments will be taken into consideration by the Government on or after the expiry of a period of one (1) month from the date of publication of this notification in the Andhra Pradesh Gazette and that objections and suggestions, if any, which may be received from any person with respect there to before the expiry of the said period, will be considered by the Government of Andhra Pradesh, Amaravati.
3. The objections and suggestions, if any, shall be addressed to the Principal Secretary to Government, Agricultural Marketing and Cooperation Department, Andhra Pradesh Secretariat, Amaravati through the Commissioner & Director of Agricultural Marketing, Andhra Pradesh., Guntur.

## **AMENDMENTS**

### **In the said rules**

1. For Rule 13 the following shall be substituted, namely:-

"Payment of Pension, Family Pension and other Pensionary benefits be disbursed by Director of Marketing online into the bank accounts of the pensioners from the fund administered by him or by the Secretary of the Agriculture Market Committee as the case may be".

2. In instruction No.7 under Appendix-II:-

(i) between the words "in cash" and "at the Market Committee" the following words shall be inserted, namely:-

"at the Office of the Director of Marketing or"

(ii) at the end of the para, the following shall be added, namely:-

"The disbursing authorities, the Director of Marketing or the Secretary of the Agriculture Market Committee shall maintain all the necessary records including electronic records, as required under the Andhra Pradesh Revised Pension Rules, 1980 as amended from time to time."
