Marketing to release 2/3<sup>rd</sup> (two thirds) amount of total principle amount (Rs.16.62 Crores) pending from M/s Sirpur Paper Mills, Khagaz Nagar, Adilabad to the farmers who supplied raw material (Subabul / Eucalyptus / Casuarina) to said paper mill from CMF Funds on reimbursement basis duly verifying the genuineness of the farmers in the interest of welfare of famers community.

In the reference 2<sup>nd</sup> read above, the Special Commissioner & Director of Agricultural Marketing has disbursed the amount to the concerned District Collectors from the Central Market Funds and as per the information report submitted by the Regional Joint Director of Marketing, Vijayawada as detailed below:
