- 1. All the instructions given in the Tender Form should be read carefully.
- 2. Tender shall be submitted in a cover containing two separate envelops where in the following documents shall be kept.

## ENVELOPE -1:

#### TECHNICALBID:

GUIDELINES TO THE BIDDER FOR SUBMISSION OF TECHNICAL BID:

- 1. This envelope should contain Annexure-I & II besides all other documents and should be super scribed as "TECHNICAL BID".
- 2. Supplier should possess the requisite Sales Tax Registration (GST) for marketing of the product (Proof to be enclosed).
- 3. Audited balance sheets of the financial year 2021-22, 2022-23 and provisional balance sheet for the year 2023-24 shall be enclosed.
- 4. Income Tax Returns with I.T. Department Acknowledgements of the last 3 years.
- 5. Copy of PAN is also required.
- 6. Turn over during previous three (3) years.
- 7. No quality complaints from Department of Agriculture (Certificate to be enclosed).
- 8. The Tenderer should provide documentary proof in support of the above to qualify for opening of price bid.
- 9. Copies of partnership deed/ Articles of Association or Bye-laws.
- 10. - 1. **Special Commissioner of Agriculture** reserves the right to accept or reject any or all the quotations in full or in part without assigning any reason. **Special Commissioner of Agriculture** is not bound to accept the lowest or any other tender and reserves the right to negotiate the rates with any or all the Tenderers.
- 2. Quotations not conforming to the instructions as per the tender documents are liable to be rejected at the sole discretion of **Special Commissioner of Agriculture.**
- 3. Technical Bids will be opened at Commissionerate of Agriculture, Guntur on 20.07.2023 at 11.00AM in presence of representative of tenderers duly authorized for negotiation, if any.
- 4. Price Bids of only those Tenderers, whose Technical Bids were found to be in conformity with the instructions as per the tender documents and without any deficiency, will be opened at Commissionerate of Agriculture, Guntur in the presence of representative/s of tenderers.

- 2. The Tenderer of the product should participate in the tenders and having Agriculture license of AP Govt. for marketing of the product. The manufacturers of Bromadiolone 0.25%CB solely responsible for the quality aspects and other terms and conditions stated in the tender schedule.
- 3. All the sealed completed tenders shall be deposited in the sealed tender box kept in the premises of Special Commissioner of Agriculture, Guntur.

7. PACKING:

- a. Packing specification with detailed description for Bromadiolone 0.25%CB shall be quoted in the tender invariably and if failed to do so will entail rejection of the tender.
- b. The packing specifications shall be as per Insecticides Act 1968 for 100gms,
- c. All the Packets shall be super scribed as "Supply under subsidy scheme & not for sale".
- 8. The Tenderers who have submitted their tender shall be bound by their offer and by the terms and conditions which will be valid upto **31.07.2024** from the date of offering the tender.
- The tenderer whose offer is accepted shall deposit an additional amount of Rs.2,00,000/-(Two lakhs only) towards security deposit within (3) three working days from the date of confirmation in addition to EMD already deposited.
- 10. Any taxes levied or leviable will be borne by the firm. In the event of nonpayment of taxes / statutory dues, the department shall have the right to recover the same from the firm.
- 11. Interest will not be payable on the Security Deposit and Earnest Money Deposit.
- 12. EMD will be returned to all the unsuccessful tenderers after the final decision on the tender. In case of successful tender (s) the EMD shall be retained.
- 13. The successful tenderer shall be required to enter into an agreement with the **Special Commissioner of Agriculture** to supply Bromadiolone 0.25%CB under departmental subsidy schemes.
- 14. All or any disputes arising out of working or interpretation of this contract shall be resolved only by process of Arbitration.

# **15. PRICE QUOTATION & QUANTITIES TERMS:**

a. Tenderers are required to quote price of each item in figures and in words (in case of dispute the later will prevail) in the Schedule of price as Annexure-III and fill in all blanks legibly and properly. Corrections, if any, shall be made out by crossing out, rewriting, signing and dating.

- b. The price quoted shall be inclusive of all taxes for all kinds of packing.
- c. The rate quoted in the Tender, shall be inclusive of packing,forwarding,freight,insurance,loading,unloading,storage, movement to anywhere of East Godavari, Kakinada, Dr.B.R. Ambedkar Konaseema, West Godavari, Eluru, Krishna, NTR, Guntur, Bapatla, Palnadu, Nandyal, Tirupati and SPSR Nellore districts of the state of Andhra Pradesh and complete in all respects.
- d. No request for price increase will be entertained, even if the orders are placed for part loads at a time for each destination.
- e. The Schedule of prices shall be firm and remain fixed during the entire currency of the contract and completion of all contractual obligations.
- f. On account of escalation in prices of the material in the market due to what so ever reason be during the period of contract, the successful Tenderers will not be entitled for any claims due to price variation over and above the approved rate. ## **17.Delivery**

- e. In case of variations in the analysis report from the conformed specification/ or misbranded, the stocks will be rejected, and the supplier is solely responsible for the action initiated by the departmental enforcing authorities and the supplier should replace the entire stocks at his cost.
- 18. The tenderers who have failed to fulfill their supply contract in the past need not participate in the tender and their bids will summarily be rejected.
